- November 18, 2009. The last rate proceeding for the water system was in Docket No. 070694-WS utilizing a test year ending June 30, 2007, which resulted on Order No. PSC-08-0827 PAA-WS, issued December 22, 2008. Wastewater rates were last set in a rate case that culminated in Order No. 20270 issued November 7, 1988. Rate base for the wastewater system was last set in Order No. PSC-98-1092-FOF-WS issued August 12, 1998.
- (d) The Application will be available for customer inspection during the time the rate application is pending as required by Commission Rules at a library closest to the service area.


