
Re: MCC Telephony of Florida, LLC Compliance with FCC ICC/USF Order

Dear Ms. Cole,

MCC Telephony of Florida, LLC ("MCC" or the "Company"), by counsel, submits this letter to confirm the Company's compliance with the access rate reduction requirements of the Federal Communications Commission's November 2011 ICC/USF Order (FCC 11-261). MCC filed tariff revisions in early 2012 which reduced the Company's intrastate terminating switched access rates to a level equal to (or in a few cases below) MCC's interstate rates. Consequently, no additional tariff revisions or submission of supporting revenue calculations needed to be made by the Company to meet the July 3, 2012 deadline for terminating access charge rate reductions.
