

LTS of Rocky Mount, LLC (LTS), pursuant to rule 25-22.006, Florida Administrative Code, requests confidential classification for certain information contained in one document attached to AT&T Florida's (AT&T) Response in Objection to Application for Authority to Provide Competitive Local Exchange Telecommunications Company Service for LTS of Rocky Mount, LLC, filed on July 24, 2012. As grounds therefor, LTS states:

1. On July 24, 2012, LTS filed an Application for Authority to Provide Competitive Local Exchange Telecommunications Company Service.
2. On August 2, 2012, AT&T filed a Response in Objection to LTS's Application for Authority to Provide Competitive Local Exchange Telecommunications Company Service.
3. On August 3, 2012, AT&T filed a Notice of Intent to Request Specified Confidential Classification for AT&T's Exhibit No. 3 to the Objection, noting that LTS would be responsible for seeking confidential classification for any information and/or document it claims are confidential.
4. Section 364.1833, Florida Statutes, provides that:

The term "proprietary confidential business information" means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the persons or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative

body, or private agreement that provides that the information will not be released to the public.

5. LTS has reviewed the documents AT&T attached to its Response and seeks confidential classification for only a portion of Exhibit No. 3 – LTS's Confidential Credit Application. The information for which LTS requests confidential classification is:


- The identity of LTS's bank and LTS's bank account number

This information falls squarely within the types of information for which confidential classification is appropriate. Failure to protect such information could compromise LTS's bank account.


