

4.1 Quasar Long Distance Service

Quasar offers four service plans, the Quasar 6-12 Plan, the Quasar 7-14 Plan, the Quasar 8-16 Plan and the Quasar One Rate Plan. Except for the One Rate Plan, the rates for each plan vary between in-state and out-of-state calls. Rates listed in this tariff are for in-state calls only.

4.1.1 Quasar 6-12 Plan

Rate per minute: 12 cents
Plan is billed in full minute increments.
Monthly fee: \$5.95

4.1.2 Quasar 7-14 Plan

Rate per minute: 14 cents
Plan is billed in full minute increments.
Monthly fee: \$5.95

4.1.3 Quasar 8-16 Plan

Rate per minute: 16 cents
Plan is billed in full minute increments.
Monthly fee: \$5.95

4.1.4 Quasar One Rate Plan

Rate per minute: 14 cents
Plan is billed in full minute increments. Minimum monthly usage: \$4.95
Monthly fee: \$5.95

4.2 Quasar Calling Card Service

Rate per minute: 19 cents
Plan is billed in full minute increments.

4.3 Directory Assistance

Directory Assistance is billed on a per call basis at a rate of 85 cents per call.
