Dear Ms. Cole:

In order to avoid the time and expense of a limited proceeding to address the reclaimed water main to connect to the City of Apopka, this project is included in this Docket as a pro-forma project. Due to the time expended when the City of Altamonte Springs wanted to participate in the project, there is a resultant delay in finalizing the plans, obtaining bids, and entering into a contract. That delay requires Sanlando to request a change in the CASR so that this matter is scheduled at the January 8 or 24, 2013 Commission Conference.

This letter is Sanlando Utilities Corporation's waiver, through January 24, 2013, of the Commission's requirement, pursuant to Section 367.081(8), Florida Statutes, to process the above-referenced case within five (5) months of the official filing date.

This letter is also Sanlando Utilities Corporation's waiver to the January 24, 2013, Commission Conference of the prohibition, pursuant to Section 367.081(6), Florida Statutes, against the Commission withholding consent to the implementation of rates in the above-referenced case for more than eight (8) months following the date of filing.
