# TAMPA ELECTRIC COMPANY'S RESPONSE TO MR. McDONALD'S OCTOBER 30, 2012 FILING

Tampa Electric Company ("Tampa Electric" or "the company"), responds as follows to the October 30, 2012 filing submitted by Mr. Edward McDonald:

- 1. Mr. McDonald's Complaint, recorded in this docket on October 16, 2012, should not be severed from this docket, as it represents but another in a series of Mr. McDonald's continuing and confusing submissions that argue and reargue to avoid paying amounts owed by Mr. McDonald to Tampa Electric for electric service it has provided to him.
- 2. Despite Mr. McDonald's assertions to the contrary in both his October 16 Complaint and his October 30 filing, Tampa Electric at all times has followed appropriate billing procedures in accordance with the Commission's rules, including providing Mr. McDonald written notification at least five business days in advance of termination that his electric service would be terminated for non-payment.
- 3. Mr. McDonald's October 30 filing, like many of his earlier filings, is confusing to the point of being unintelligible and does not present any basis for any relief.
