**RE:** Recommendation to Office of the General Counsel - Docket No. 120310-TL – Petition for expedited review of growth code denials by the Number Pooling Administration for the Orange Park exchange (Ridgewood) by AT&T Florida.

On November 28, 2012, AT&T Florida filed a request for additional numbering resources from the Number Pooling Administrator (NeuStar) for the Orange Park exchange, Ridgewood (ORPKFLRWDS0) switch. AT&T Florida requested a single number block of 5,000 numbers in the format of NPA NXX-0,1,2,3,4 to meet the request of a specific customer. On November 28, 2012, AT&T Florida's request for additional numbering resources was denied because it did not meet the utilization criteria.

On December 10, 2012, AT&T filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Section 2.07C.5.e of the Administrative Procedures Manual (APM), staff has examined the AT&T Florida petition and has determined the following:

- 1) The carrier has demonstrated that it has customers in need of numbering resources;
- 2) The carrier has shown that it will be unable to provide services to these potential customers because of NeuStar's denial of the numbering resources; and
- 3) Customers will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of Section 2.07C.5.e of the APM have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (January 2, 2013), as outlined in the APM expedited code denial process. NeuStar should be directed to provide AT&T Florida the needed numbering resources to meet its customer's needs in the Orange Park exchange, Ridgewood (ORPKFLRWDS0) switch.
