The Commission received your request for voluntary pay telephone certificate cancellation effective January 1, 2013.

I would like to clarify that you plan to pay the minimum \$100 RAF payment on or before January 30, 2013 and submit the 2012 RAF completed with zero revenues.

If you submit the RAF payment by its due date (**postmarked no later than January 30, 2013**), the cancellation request can be retroactively effective December 31, 2012.
