On February 7, 2013, Peninsula Pipeline Company, Inc. (Peninsula) filed a Request for Confidential Classification (Request) for information contained in Revised Attachment A (DN 00760-13; x-ref. DN 00761-13) of its Amended Transportation Service Agreement with Florida Public Utilities Company (FPUC). The Company had previously asked for confidential classification of the same information set forth in the original Attachment A on December 20, 2012. After reviewing the original request, staff recommended that it be granted (see DN 08329-12) because disclosure of the redacted information could harm both Peninsula and FPUC's business operations and ratepayers by impairing the Companies' respective abilities to effectively negotiate for goods and services. Staff believes the same is true for the information contained in the revised attachment and as such, recommends the Request be granted.
