ORDER GRANTING DEBTORS' EMERGENCY MOTION PURSUANT TO § 362 TO PROVIDE PAYMENT ASSURANCE AND AUTHORIZING SETOFF OF CERTAIN PROVIDER CONTRACTS

CAME ON FOR CONSIDERATION the Motion of UPH Holdings, Inc., (“UPH”), Pac-West Telecom, Inc., (“Pac-West”), Tex-Link Communications, Inc. (“Tex-Link”), UniPoint Holdings, Inc. (“UniPoint Holdings”), UniPoint Enhanced Services, Inc. (“UniPoint Enhanced”), UniPoint Services, Inc., (“UniPoint”), nWire, LLC (“nWire”), and Peering Partners Communications, LLC (“Peering Partners”) (collectively the “Debtors”), Pursuant to § 362 to Provide Payment Assurance and Authorizing Setoff of Certain Provider Contracts (“Motion”). The Court, having considered same, and any response(s) thereto, and found that notice of the Motion was proper, is of the opinion that the Motion should be, and is hereby GRANTED in its entirety; it is therefore
