MS. BRUCE: Yes. Commissioners, Sonica Bruce. Commission staff has on oral modification on Page 34 of the recommendation at the bottom of the page. In the section titled wastewater service availability charges, the plant capacity charge should be \$765 per ERC for residential customers and \$2.83 for all others. The main extension charge should be \$2,268 per ERC for residential customers and \$8.40 for all others. Thank you.
