(see Docket No. 110253-TX, Certificate No. 8366). A copy of Order No. PSC-11-0437-FOF-TX is attached hereto for your reference. Please be advised that Zone Telecom, LLC ("Zone") has changed its name to ANPI Business, LLC ("ANPI Business").

Also attached hereto please find a copy of the Certificate of Amendment issued by the State of Delaware as well as the Name Change Filing acknowledgement by the Florida Department of State, Division of Corporations.

In addition, please find an original and one (1) copy of the revised sheets for ANPI Business's Florida local exchange communications services tariff. ANPI Business has not changed any rates, regulations or conditions of service as a result of this name change, and the enclosed tariff sheets have been updated only to reflect the company name, address, and contact changes. The following is a brief description of the changes:

ORDERED that this change will be effective upon issuance of this Order. It is further



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request:

- 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or




