RE: Administrative approval of a transfer to a governmental entity in Docket No. 130050-WS, Joint notice of application for approval of transfer of certain water and wastewater facilities of Aqua Utilities Florida, Inc. in Alachua, Hardee, Lake, Lee, Marion, Orange, Pasco, Polk, Putnam, Seminole and Volusia counties, to the Florida Governmental Utility Authority, and request for cancellation of certificates.

Aqua Utilities Florida, Inc. (Aqua or Utility) is a Class A water and wastewater utility providing service to approximately 18,187 water and 17,493 wastewater customers in Alachua, Hardee, Lake, Lee, Marion, Orange, Pasco, Polk, Putnam, Seminole and Volusia counties. Water and wastewater rates were last established for this Utility in its 2010 rate case.¹

On February 20, 2013, Aqua filed an application for transfer of certain water and wastewater facilities to the Florida Governmental Utility Authority (FGUA) and cancellation of those certificates. Pursuant to Section 367.071(4), Florida Statutes (F.S.), the sale of facilities to a governmental authority shall be approved as a matter of right. As such, no notice of the transfer is required and no filing fees apply.

The application included an Agreement for Purchase and Sale of Water and Wastewater Assets between Aqua and FGUA, which closed March 22, 2013, the effective date of the transfer. Pursuant to Section 367.071(4)(a), F.S., and Rule 25-30.037(4)(e), Florida Administrative Code (F.A.C.), the Utility included a statement that the FGUA obtained the most recent income statements, the most recent balance sheet, statement of rate base for regulatory purposes, and contributions-in-aid-of-construction. In accordance with Rule 25-30-037(4)(g), F.A.C., the Utility specified that it applied deposits to any customer account with a past due balance. For the remaining deposits, Aqua applied the interest to the customers' accounts and the remaining balance has been transferred to the FGUA. On April 23, 2013, Aqua filed its 2012 annual report pursuant to Rule 25-30.110, F.A.C. The Utility is required to pay all outstanding regulatory assessment fees by July 1, 2013. The Utility will not be under the Commission's jurisdiction on December 31, 2013; therefore, no annual report needs to be filed for 2013.

Also, pursuant to Section 2.07(c)(4)(d) of the Administrative Procedures Manual, staff has been given administrative authority to approve transfers to governmental entities that are in compliance with Section 367.071(4)(a), F.S. and are not controversial in nature. Based on the above, staff believes that the application is in compliance with Section 367.071(4)(a), F.S., and Rule 25-30.037(4), F.A.C. Staff recommends that the Commission acknowledge the transfer of the water and wastewater systems to the FGUA as a matter of right, pursuant to Section 367.071(4)(a), F.S., and cancel the certificates listed below effective March 22, 2013. In addition, staff recommends that the docket be closed because no further action is necessary.
