BEFORE ME, the undersigned authority duly authorized to administer oaths, personally appeared Lee Guthrie, who being first duly sworn, on oath deposes and says that:

1. My name is Lee Guthrie. I am over the age of 18 years old and I have been authorized by Duke Energy Florida, Inc. (hereinafter "DEF" or the "Company") to give this affidavit in the above-styled proceeding on DEF's behalf and in support of DEF's Request for Confidential Classification. The facts attested to in my affidavit are based upon my personal knowledge.

2. I am the Manager of Florida Regulatory Strategy in the Customer Planning and Analytics Department. This section is responsible for regulatory planning, support and compliance of the Company's Demand-Side Management (DSM) programs.

3. As the Manager of Florida Regulatory Strategy, I am responsible, along with the other members of the section, to ensure that all customers meet specific

requirements to participate in the Company's Residential & Commercial Photovoltaic Programs.

4. DEF is seeking confidential classification for portions its Responses to Staff's Solar Panel Recall Data Request submitted to Staff on June 14, 2013. The confidential information at issue is contained in confidential Exhibit A to DEF's Request for Confidential Classification and is outlined in DEF's Justification Matrix that is attached to DEF's Request for Confidential Classification as Exhibit C. DEF is requesting confidential classification of this information because it contains names and addresses of customers who have had certain Blue Chip panels installed, the disclosure of which would cause harm to those customers. The disclosure could harm the customer's rights to privacy.

5. The aforementioned discovery sought by Staff should be afforded confidential treatment because portions of the responses to these data requests, specifically responses to questions 8 and 11, contain names and addresses of customers who have had certain Blue Chip panels installed. The Company does not disclose information like customer names, addresses, and equipment installation information to the public, because it considers that information confidential and private information that belongs to its customers. By disclosing the customer names and addresses to the public, it would cause harm to those customers.

6. Strict procedures are established and followed to maintain the confidentiality of the names and addresses of customers who have had certain Blue Chip panels installed, including restricting access to those persons who need the information to assist the Company, and restricting the number of, and access to the information. At no

time since receiving the information in question has the Company publicly disclosed that

information. The Company has treated and continues to treat the information and

contracts at issue as confidential.
