Re: Notification of Pro Forma Transaction and Surrender of Authorization of USCarrier Telecom, LLC

Dear Ms. Cole:

Zayo Group, LLC ("Zayo"), individually and as the successor in interest to USCarrier Telecom, LLC ("USCarrier") (together the "Parties"), hereby notifies the Commission that on June 21, 2013, the Parties completed the roll up of USCarrier into Zayo.¹ As a result, USCarrier no longer exists as a separate corporate entity. To the extent necessary, Zayo surrenders the authorization of USCarrier (Company Code TJ366)² and withdraws USCarrier's tariffs on file with the Commission. Further, in the event that USCarrier has a current bond or letter of credit on file with the Commission, Zayo requests that the Commission authorize the cancellation of the bond or letter of credit and return it to Zayo.

¹ The roll up resulted from the merger of USCarrier with and into USCarrier Telecom Holdings, LLC ("USC Holdings"), whereupon the separate existence of USCarrier ceased and USC Holdings was the surviving entity, immediately followed by the merger of USC Holdings with and into Zayo, whereupon the separate existence of USC Holdings ceased and Zayo was the surviving entity. Zayo continues to operate under Certificate of Authority No. 8836.
