

FAR NOTICE OF PREHEARING AND HEARING

The FLORIDA PUBLIC SERVICE COMMISSION announces a prehearing conference and a hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE: Docket No. 130040-EI - Petition for rate increase by Tampa Electric Company.

PREHEARING CONFERENCE DATE AND TIME: Monday, August 26, 2013 at 1:00 pm

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of the meeting is to permit parties to present testimony and exhibits relative to the application by Tampa Electric Company, and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony on the issues identified by the parties at the prehearing conference held on August 26, 2013.
