QSI CONSULTING, INC.'S SECOND FEE REQUEST FOR PAYMENT OF COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR THE PERIOD FROM JULY 1, 2013 THROUGH AND INCLUDING JULY 31, 2013

TO THE HONORABLE TONY M. DAVIS:

A TIMELY FILED RESPONSE IS NECESSARY FOR A HEARING TO BE HELD.

QSI Consulting, Inc. ("QSI") has applied, pursuant to the Order Granting

Debtors' Motion for Order Establishing Monthly Fee and Expense Reimbursement Procedures

(the "<u>Procedures Order</u>") entered by this Court on May 15, 2013 (Docket Entry No. 186), for payment to QSI of interim compensation for services rendered and reimbursement of expenses incurred during the period commencing July 1, 2013 through July 31, 2013.<sup>1</sup>

QSI seeks payment of interim compensation in the total amount of \$2,236.67.

This total is 80% of the fees for services rendered. QSI incurred no expenses during this time period. Summaries of the fees are attached hereto as Exhibit A.

Pursuant to the Order, any party objecting to the payment of interim compensation and reimbursement of expenses as requested must file a written objection with the Court and serve a copy delivered by U.S. mail and e-mail to the following parties within ten (10) days after the date of mailing this notice:

Any disputed amount must have a description of the objection to each line item in dispute; it shall not be sufficient to simply object to all fees and expenses.
