3 Number 2.

4 **MS. COWDERY:** Good morning, Commissioners.

5 My name is Kathryn Cowdery with the Office of
6 General Counsel. Item 2 is the proposed adoption of
7 Rule 25-6.0431, petition for limited proceeding for
8 electric utilities, and Rule 25-7.0391, petition for
9 limited proceeding for gas utilities, and the amendment
10 of Rule 25-22.0406, notice and public information on
11 general rate increase requests for electric and gas
12 utilities.

13 Staff is recommending that the Commission
14 propose adoption of rules which identify the
15 information required in a petition for limited
16 proceeding for electric and gas utilities. Staff is
17 also recommending that the noticing rule be amended to
18 include provisions relating to limited proceedings, and
19 also that it be updated to reflect changes in
20 technology.

21 Staff is available to answer any questions.

22 **CHAIRMAN BRISÉ:** Thank you very much.

23 Commissioners, I don't know if there are any
24 questions on this item. I know I don't have any.

25 Thank you very much for your presentation on

1 this item. And I think that as we are going through
2 our rules, it's important for us to make sure that they
3 stay up with what is our current reality, and I think
4 that these changes do just that.
