PREHEARING STATEMENT**

Pursuant to the requirements of the Order on Procedure, Order No. PSC-13-0101-PCO-GU, as subsequently modified, Florida City Gas hereby submits its Prehearing Statement.

A. Known Witnesses

Florida City Gas intends to offer the 2012 true-up testimony of Thomas Kaufmann, as filed on April 29, 2013, as well as the true-up factor testimony of Mr. Kaufmann, as submitted on September 10, 2013.

Thomas Kaufmann Issues 1-5

B. Known Exhibits

Florida City Gas intends to sponsor the following exhibits:

C. Basic Position

Florida City Gas has appropriately calculated its true-up amounts and purchased gas adjustment factor as shown in the Company's positions on Issues 1-5.

D. – F. Issues

Florida City Gas' position on the issues identified by Staff are as follows:

Issue 1: What are the final purchased gas adjustment true-up amounts for the period January 2012 through December 2012?

Florida City Gas: An over-recovery of \$1,408,722.

Issue 2: What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2013 through December 2013?

Florida City Gas: An under-recovery of \$1,312,868.

Issue 3: What are the total purchased gas adjustment true-up amounts to be collected during the period January 2014 through December 2014?

Florida City Gas: An over-recovery of \$95,854, for a true-up refund factor of 00.225 cents per therm.

Issue 4: What are the levelized purchased gas cost recovery (cap) factors for the period January 2014 through December 2014?

Florida City Gas: Based on the winter months of October through March the appropriate (cap) factors are, 86.233 cents per therm (before the regulatory assessment fee) or 86.666 cents per therm (with the regulatory assessment fee).

Issue 5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

Florida City Gas: The factors should be effective for all meter readings on or after January 1, 2014 and should apply for bills rendered for meter readings taken between January 1, 2014 and December 31, 2014.

G. Stipulated Issues

Florida City Gas is not a party to any stipulations at this time, although it believes that it should be possible to reach a stipulation on each of the above issues as they relate to Florida City Gas.

H. Pending Motions

None at this time.

I. Pending Confidentiality Requests

Florida City Gas has no pending requests for confidentiality.


J. Compliance With Order on Procedure
