St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Prehearing Statements for the hearing scheduled to commence in the proceeding November 4, 2013.

A. Witness that may be called:

C. Statement of Basic Position:

The Commission should approve the final adjusted net true-up amount for the twelve month period ending December 31, 2013 including interest, the projected conservation program expenses for the twelve month period ending Dec 31, 2014 and the Conservation Cost Recovery Factors to be applied to customer bills rendered for the twelve month period ending December 31, 2014 as filed by SJNG.

D. SJNG's position on each issue:

1. What are the final conservation cost recovery true-up amounts for the period January 2012 through December 2012?

SJNG: An under-recovery of \$78,459

2. What are the actual/estimated conservation cost recovery

true-up amounts for the period January 2013 through December 2013?

SJNG: An under-recovery of \$48,730.

3. What are the total conservation cost recovery amounts to be collected during the period January 2014 through December 2014?

SJNG: Total conservation cost recovery is \$104,680.

4. What is the appropriate Conservation Cost Recovery Factor to be applied to customer bills during the twelve month period ending December 31, 2014?

SJNG: \$0.23774 per therm for RS-1, \$0.15696 per therm for RS-2, \$.12258 per therm for RS-3, \$.11254 per therm for GS-1, \$.04466 per therm for GS-2, and \$.02049 per therm for FTS-4.

5. What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG: The effective date should be January 1, 2014.
