
Dear Ms. Cole:

On July 15, 2013, Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Communications ("Birch") and Lightyear Network Solutions, LLC ("Lightyear") (collectively, "Parties") filed a Notification with the Florida Public Service Commission ("Commission") of the transfer of the assets and customers of Lightyear to Birch (the "Transaction").
