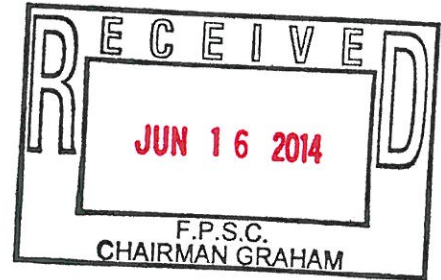

As you may know, Sabal Trail Transmission, LLC's (Sabal Trail) interstate pipeline system is a proposed pipeline project in Alabama, Georgia, and Florida, and is currently under environmental review in the Federal Energy Regulatory Commission (FERC) Pre-filing process in Docket PF14-01-000. Say the words "Spectra Energy" and watch the email inbox light up.

Spectra is the company that is partnering with Florida Power & Light to build a natural-gas pipeline through three states, including Florida and parts of Lake, Sumter, Marion, Polk and Osceola counties.

The company is well known for building pipelines, and a spokesman said last week that it has a better safety record for onshore pipelines than does its competitors.

Folks who live around Spectra's projects don't feel the same way. Take Mike Benard, a New York resident whose property in Pennsylvania was taken by Spectra in an eminent-domain proceeding to build a 12-billion-cubic-foot underground reservoir for natural gas on 43 acres, complete with a 5,000-horsepower compressor station and 13 injection and withdrawal wells.

Benard runs an operation that used to be called Spectra Energy Watch but now has expanded and can be found at shalepropertyrights.com.

His biggest quarrel with the company is that, backed by the federal government, Spectra runs over the rights of property owners. That's an ages-old argument against eminent domain that Benard won't be winning. Another of his complaints is that the company likes to call its neighbors "stakeholders" but treats them like the enemy.

"Spectra Energy is a company that will not answer questions (especially from its 'stakeholders'), and it will not talk about its performance record, including federal and state fines," Benard wrote in an email. "If communities and local governments want to know what to expect from Spectra Energy, ask folks who live with its facilities today."

Benard cited an incident last March at the Steckman Ridge storage facility in which smoke was coming from a compression station and the local fire department responded. Residents, sitting atop an underground potential bomb, were rightly nervous. A spokesman for the company said there was no smoke, no incident and nothing was released.

Six days later, a headline in the Bedford (Pa.) Gazette declared, "Spectra backtracks on gas incident" and the story went on to detail how a pressure-release valve tripped, sending methane, the main ingredient in natural gas, into the air.

Benard said his organization has been talking with people who live along the 473-mile route of the proposed Sabal Trail pipeline, which accounts for about half the miles of pipeline that Spectra currently is trying to get approved by the federal government.

Slowly, folks in this area are beginning to realize that a pipeline is being proposed, and they could end up living nearby.

One who is a jump ahead on the issue is Gertrude Dickinson, a Lake Panasoffkee resident whose property is adjacent to the Half Moon Wildlife Management Area.

Dickinson has been fighting the pipeline both for personal health reasons and because she fears it could damage the environment.

The 83-year-old retiree who taught for 43 years at inner-city schools in Miami, said she suffers from a condition called auditory recruitment in which normal sounds are heard many times louder than they are heard by normal ears. The effect, Dickinson said, sets her nerves on edge and drives her blood pressure to unsafe levels. She dreads what will happen if the pipeline is installed near her property.

She said the pipeline route (see bit.ly/1fHVtXx) runs directly through the Half Moon area, where rangers ignite controlled burns once a year.

"A leak would be disastrous to the wildlife area and all of those in the Rutland Ranch development that is located directly adjacent to Half Moon," Dickinson wrote in an email.

Yeow! Controlled burns over top of a buried natural gas pipeline. Gee, nothing could go wrong there, could it?

Natural gas may be among the best fossil fuels when it comes to preserving the environment, but that doesn't mean companies should get an automatic pass on where and how to build a pipeline. But they will — unless the public gets involved.

The next public meeting on this issue is set for 6 p.m. Thursday at the Citrus Tower in Clermont.

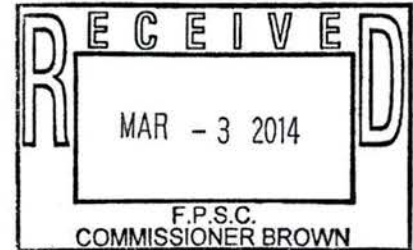

Dear Ms. Brown:

I would like to thank you for your continued interest in the Sabal Trail Project throughout the early project development phase and take this opportunity to provide you with a brief update on project-related outreach. Specifically, I would like to provide you with information on upcoming Sabal Trail Project scoping meetings to be hosted by the Federal Energy Regulatory Commission ("FERC").

As you are aware, the Sabal Trail Project is a proposed interstate natural gas pipeline system that will be capable of transporting roughly 1 billion cubic feet per day of natural gas to serve local distribution companies, industrial users, and natural gas-fired power generators in the Southeast markets. Over the last several months, our Sabal Trail team has hosted 23 voluntary informational meetings and 21 formal open houses in communities along the proposed project corridor. These meetings have provided members of these communities and specifically, potentially affected landowners, the opportunity to learn more about the proposed project and potential route¹⁸⁵, the regulatory process, engineering, safety and environmental considerations that factor into project routing and design criteria. Just as important, these meetings have allowed stakeholders to provide input directly to our project team during this early development phase of the project.

FERC exclusively authorizes the construction of new interstate natural gas facilities, such as the Sabal Trail Project, and is also the lead federal agency responsible for conducting environmental reviews of interstate natural gas projects, in compliance with the National Environmental Policy Act (NEPA). On February 18, 2014, FERC issued a Notice of Intent to Prepare an Environmental Impact Statement ("EIS") for the Planned Southeast Markets Pipeline Project which includes the Sabal Trail Project, a Request for Comments on Environmental Issues, and a Notice of Public Scoping Meetings ("NOI") in Docket Nos. PF14-

1-000, FP14-2-000 and PF14-6-000. Docket No. PF14-1-000 is specific to the Sabal Trail Project. The NOI is issued as part of FERC's review to satisfy the requirements of NEPA and announces the opening of the scoping process. A copy of the NOI is posted on Sabal Trail's webpage (www.sabaltrail.com) under the resources tab.

As part of this process, FERC will hold scoping meetings to gather input about the Project from the public and other interested stakeholders. These scoping meetings enable FERC's staff to identify relevant issues of major concern and define or refine the scope of the EIS. Information gathered during the scoping meetings will also help Sabal Trail prepare its environmental resource reports.

During these scoping meetings, FERC staff will describe the environmental review process, provide relevant information about the Project, and answer any procedural questions. These scoping meetings provide stakeholders with an opportunity to make statements and directly address the FERC staff regarding the Sabal Trail Project.

Comments on the proposed project may also be submitted in writing, in addition to comments made verbally during the scoping meeting. These comments will become part of the formal record of FERC's proceeding on the Project. Please note that the NOI sets the close of the scoping period on April 20, 2014. For your information, attached, is page 2 of FERC's NOI which lists the date, time and location of these scoping meetings. In addition, Sabal Trail representatives will be available before and after the scoping meetings should you or your constituents have questions or comments.

The proposed Sabal Trail interstate pipeline will safely and reliably increase energy diversity and security to southeastern markets. In addition, the project will create a significant number of jobs and add capital investment and tax base to affected communities in Alabama, Georgia and Florida. Our project team is actively engaged in a comprehensive consultation and ongoing communications with stakeholders – including your community. This outreach will continue throughout the regulatory review process.

FPL to pitch PSC on emissions charge increase

TALLAHASSEE — When the federal government issued new air quality guidelines in 2010 to protect the elderly, children and people with asthma from nitrogen oxide emissions, Florida Power & Light took notice.

The 48 gas turbines the company uses to fire up quickly during peak demand rely on 1970s-era technology. Although the company touts a record of having power plants “67 percent cleaner than the national average,” it also acknowledges these older so-called “peaker” plants emit some of the most toxic pollutants.

In order to comply with the new standard, FPL decided to replace all peak-demand turbines between now and 2016 and, in June, it proposed a \$822 million project. The costs would be borne by customers based on a monthly fee — FPL estimates it is less than 75 cents a month for customers using 1,000 kilowatt hours — and added to the portion of the bill used to comply with environmental regulations.

The proposal would allow the company to replace aging generators in Broward and Lee counties, avoid a lengthy rate review by utility regulators, update emissions technology and still give the company a revenue boost that would increase profits.

On Tuesday, FPL will ask the Public Service Commission to dismiss its proposal while it conducts a series of environmental tests. The goal, the company said, is to come back and ask for the rate increase again once tests are complete.

“It could be the same project; it could be a different project,” said Mark Bubriski, FPL spokesman. When the new proposal does come back, it will have to overcome several hurdles.

The Florida Department of Environmental Regulation, which regulates power plant emissions, said it wanted FPL to conduct tests first to determine the extent to which the existing plants are polluting now.

JR Kelly, director of the Office of Public Counsel, which represents consumers in utility cases, opposes FPL’s request, calling it an inappropriate use of the environmental cost recovery clause. He said FPL should go through a full rate review. Kelly also suggested FPL had not explored less expensive alternatives, such as purchasing other power plants rather than replacing its old ones.

The companies paying some of the biggest utility bills, the Florida Industrial Power Users Group, said complying with federal regulations “does not compel FPL to install new generating capacity” and FPL is not allowed to raise its rates until 2017 under the terms of a settlement agreement it entered into with them.

Even environmentalists are not siding with FPL on this one.

“This is another example of where FPL is gaming the regulatory system to add to their rate base,” said Susan Glickman, Florida director of the Southern Alliance for Clean Energy. “We have no confidence these are legitimate costs because Florida does not have a transparent, least-cost utility planning process. We should look at how solar and energy efficiency competes to get the best deal for consumers.”

Because peaker plants fire up during the hottest summer days and coldest winter nights, often at times when auto traffic is heaviest, the odds of the plants violating federal standards are high, Bubriski said.

Nitrogen oxide is formed from vehicle, power plant and industrial emissions and the new federal standard requires concentration of the dangerous gases not exceed the standard within a one-hour period. The previous standard had been based on a yearly average of emissions.

Bubriski said FPL is committed to its project, and to using the environmental cost recovery clause that allows the PSC to approve it as a pass-through cost, even if it allows it to avoid the deeper scrutiny of a rate review. He said the company used the clause to pay for construction of its solar power plant in Arcadia, for example.

“This is what we have determined to be the most cost-effective to our customers,” he said. “We believe we need to comply. We’re proud of our clean record. This is the right thing to do.”

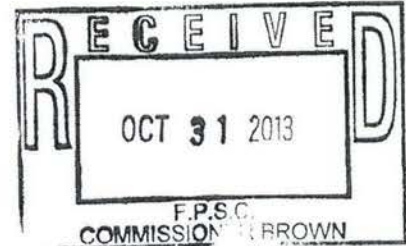

As we've previously communicated with you, Sabal Trail Transmission, LLC, a joint venture between Spectra Energy Corp and NextEra Energy, Inc., is developing a natural gas pipeline project to meet the growing demand for natural gas by electric generation, distribution and end use markets in the Southeast US. The currently proposed scope for the project includes a 470 mile, 36-inch diameter pipeline and related facilities to deliver approximately one million dekatherms of natural gas per day (about 1 billion cubic feet per day) beginning in May 2017 ("Project").

On October 16, 2013, Sabal Trail received approval to utilize Federal Energy Regulatory Commission's ("FERC") Pre-Filing Review Process, which is designed to provide for the early identification and resolution of potential environmental and landowner issues as part of FERC's initial environmental review of the Project pursuant to the National Environmental Policy Act. FERC assigned Docket No. PF14-1-000 to the Sabal Trail Project and this reference number can be used to follow updates on the Project on FERC's website, www.ferc.gov. For persons unable to access FERC's website, requests for information may be submitted to the Federal Energy Regulatory Commission, 888 First Street, N.E., Washington, D.C. 20426.


FERC regulates the interstate transmission of natural gas and plays a key role in the development of interstate natural gas pipeline projects. In order to facilitate early public interaction and discussion about a project, FERC has established a voluntary and optional pre-application review process, called the Pre-Filing Review Process. The Pre-Filing Review Process provides all stakeholders - including FERC, Federal and State agencies, and landowners, along with impacted public officials with the opportunity to review project-related information and identify issues prior to the submittal of an application for a Certificate of Public Convenience and Necessity. Sabal Trail believes the Pre-Filing Review Process is an effective way to allow for early participation and input from key stakeholders as the proposed route for the Project is being evaluated. Sabal Trail plans to file the certificate application for the Project by the fourth quarter of 2014.

Sabal Trail voluntarily hosted a total of 18 public informational meetings about the Project in various locations along the proposed pipeline corridor from October 1 - 23, 2013. With the FERC Pre-Filing Review Process now underway, Sabal Trail has moved to the next phase of our outreach efforts.

Sabal Trail intends to file with the FERC, draft Resource Report 1 (a detailed Project Description) and Resource Report 10 (Route Alternatives) on November 15, 2013. These documents will be available for public review on FERC's website. Copies of these documents will also be placed in public libraries for stakeholder access. In December 2013, we will host a number of official Open Houses in coordination with FERC. We invite your participation in these meetings to learn more about Project status and the certification process as well as to meet informally with Project personnel, who are available to answer any questions you may have. The dates and locations for the Open Houses are available on www.SabalTrail.com and are accessible on FERC's website.
