The following questions relate to the August 2, 2013 testimony of Don Grissette filed in Docket No. 130001-EI.

Has FPL estimated a cost for the bulleted list on page 5 of the witness's testimony?

a. If yes, please provide FPL's estimates.

A.

FPL does not track the costs by the categories identified on the bulleted list on page 5 of the testimony and has not fully estimated the costs of the Fukushima Response Program at this time. However, FPL has identified a range of expected costs for the combined Turkey Point and St. Lucie effort which will fall within the categories identified on the bulleted list. The range is between \$93M and \$189M through the end of 2016. This estimate is for the cost of the proposed requirements in response to the immediate actions and does not include short term and long term requirements.


