SECTION 63.71 APPLICATION

Telefonica Digital, Inc. ("TDI"), in accordance with Section 63.71 of the

Commission's rules,¹ hereby requests authority to discontinue the provision of wholesale

domestic telecommunications services within the United States.²

In support of this application, TDI provides the following information in

accordance with Section 63.71(b) of the Commission's rules:

Name and address of carrier

Telefonica Digital, Inc. 200 W. Evelyn Ave., # 120 Mountain View, CA 94041

Planned discontinuance date and geographic areas affected

TDI plans to discontinue its wholesale telecommunications services as of January 1, 2014, or as soon thereafter once the necessary regulatory approvals have been obtained. The affected geographic service area is national.

² TDI (which in the past operated under the trade name Jajah, Inc.) also will discontinue its provision of wholesale international telecommunications service, and the company today is notifying the International Bureau of the proposed discontinuance under separate cover in accordance with 47 C.F.R. § 63.19. Furthermore, TDI expects to discontinue the provision of all retail domestic and international telecommunications services in the U.S. in early 2014. TDI will be notifying all affected retail customers and expects to file an application with the Commission to discontinue those services after the notification process is complete.

Description of affected service

As relevant to this application, TDI operates as a reseller and wholesale provider of interstate and international transmission capacity. As a general matter, TDI purchases capacity from a range of other carriers and either uses that capacity for its own retail services, uses it in connection with its own information services or those it develops in partnership with others, or resells that capacity to others at wholesale prices. This discontinuance application pertains only to the capacity that TDI resells to others at wholesale prices.

Brief description of the dates and methods of notice to all affected customers

TDI has only 20 wholesale customers. On November 14, 2013, TDI notified each of its 20 affected wholesale customers by e-mail of the proposed discontinuance, using the contact e-mail address each customer maintains with TDI. TDI routinely communicates important service-related information to these customers by e-mail, including documents such as billing statements and similar notices. TDI therefore is confident that each of the 20 wholesale customers received its e-mail notice. Prior to sending its formal discontinuance notice, TDI also discussed the planned discontinuance of wholesale services individually with each of its 20 wholesale customer received the e-mail containing the formal discontinuance notice, a copy of which is attached to this application as Exhibit <u>A</u>.

In accordance with Section 63.71(a) of the Commission's rules, copies of this application are being submitted to the public utility commission and governor of each affected state and the District of Columbia, as well as to the Special Assistant for Telecommunications to the Secretary of Defense.

Carrier's regulatory classification

TDI is classified as non-dominant with respect to the services at issue in this application.

Additional information

Any questions relating to this application may be directed to undersigned counsel for TDI.

Conclusion

The proposed discontinuance of TDI's wholesale telecommunications services will not adversely affect the public convenience or necessity, as reasonable substitutes for these services are available from numerous competing carriers. TDI therefore respectfully requests that the Commission grant TDI the requested authority to discontinue its provision of the services described herein.
