6           Item 5 is staff's recommendation addressing  
7 Peoples Water Service Company of Florida's amended filing  
8 for a limited proceeding rate increase. Peoples Water  
9 requested a limited proceeding rate increase in order to  
10 achieve the revenue previously authorized in its last  
11 rate case to recover additional revenues approved through  
12 price indices since the order in that case and for an  
13 allowance related to rate case expense.

14           Staff recommends approval of the amended filing  
15 with certain adjustments to requested rate case expense.  
16 I don't see representatives of the company or Public  
17 Counsel here to speak; staff's available for any  
18 questions.
