This letter is being sent on behalf of all of the signatories (Gulf Power Company, Office of Public Counsel, Florida Industrial Power Users Group, Federal Executive Agencies and Walmart Stores East, L.P. and Sam's East Inc., hereinafter "the Parties") to the Stipulation and Settlement Agreement (Settlement) filed with the Florida Public Service Commission in this docket on November 22, 2013 as part of FPSC Document No. 07112-13. The purpose of this letter is to reiterate the express intent of the Parties with regard to the contents of the settlement record that is contemplated in the event the Commission votes to approve the Settlement as requested by the Parties through their Joint Motion for Approval that is likewise part of FPSC Document No. 07112-13.

As provided in paragraph 12 of the Settlement, the Parties contemplated that the settlement record would contain, at a minimum, the following documents on file in this proceeding:


the petition that initiated this proceeding
