The following are the responses of CHC VII, Ltd. (CHC or Utility) to the Staff's First Data Request dated December 19, 2013.

1. Please provide a current, detailed breakdown of all salaries, directly incurred and allocated, for which the Utility is seeking recovery in this docket. In your response, please include the employee name, salary/hourly wage, a detailed description of duties performed and the percentage of time spent for each duty, as well as a detailed breakdown of how their salary is allocated to CHC.

Response. The salary amounts and allocations were provided to the audit staff pursuant to a Request for Confidential Classification (Documents No. 06876-13)

2. Please describe any management fees paid by the Utility, including the amount of the management fees, and what services are provided by the management companies.

Response. There are no management fees paid by the Utility.

3. Please estimate the amount of rate case expense for this case, both to date and through the Proposed Agency Action phase, and provide a detailed breakdown of all costs. The estimate should reflect cost reductions due to the cases for two related companies being processed simultaneously. Provide a detailed breakdown of these cost reductions.

Response. In addition to the legal rate case expense as set forth on the enclosed schedule and the \$2,000 filing fee, the Utility will incur the expense of mailing the customer meeting notice and final notice of \$903.76, broken down as follows:

4. Please state how working these two cases together reduced rate case expense.

Response. The savings in legal rate case expense have been material as a result of these two cases being processed simultaneously. Many of the responses to the auditors and addressing confidential salary information and the Staff's First Data Request have been practically identical which results in less time in responding and thus less fees. Further, scheduling both matters on the same agenda allows the fees and costs of attendance to be split in half.
