Dear Ms. Stauffer:

This letter is to notify the Commission that Qwest Communications Company, LLC d/b/a CenturyLink QCC has changed its name to CenturyLink Communications, LLC. This change is in conjunction with the consolidation of the CenturyLink IXC and CLEC entities as set forth in the Notice filed separately on this same day. Customers have been notified of this change.

The sole surviving legal entity as a result of the consolidation and name change is CenturyLink Communications, LLC, which is the name that the company will use in its published schedules and contracts in terms of providing service to end-users. However, the company is retaining d/b/a's in some states for purposes of retaining continuity with certain vendors, including other telecommunication companies with whom this entity has an ICA. Florida is one such state, so this name change filing includes the d/b/a of Embarq Communications.

A copy of the Florida Secretary of State documentation reflecting these changes is attached. Therefore, the name for the company should be reflected on Certificate No. 5801 as "CenturyLink Communications, LLC d/b/a Embarq Communications."

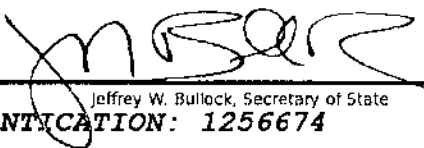
