Also attached are documents which comprise the final FCC Form 481 submission to USAC on behalf of Verizon Florida:



I, Jeanmarie Milla, being first duly sworn, state that:

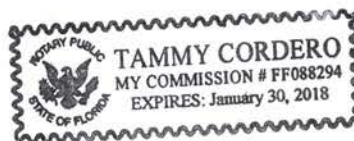
