The Board believes that the issues raised by its Petition and subsequent filings merit additional time and consideration by the Commission. In addition, the Board believes that in order to participate in good faith in the Chapter 164 conflict resolution process currently underway involving the Town of Indian River Shores, the City of Vero Beach, and Indian River County that it would be appropriate to extend the 90-day requirement.
