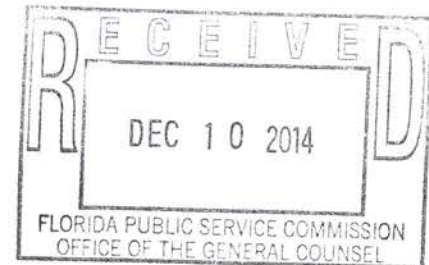

We are writing in response to your comments on the above-referenced rules. We have considered your comments and prepared the following responses.

25-7.014(6): Is the acronym "MCF" used in this subsection defined elsewhere in this rule chapter? If not, please define.

The acronym "MCF" used in this subsection is not defined elsewhere in this rule chapter. We made a technical change to the proposed rule and have added the words that this acronym represents. "MCF" is an acronym for "thousand cubic feet" and the language "thousand cubic feet (MCF)" is now in the body of the rule.

25-7.015: Rulemaking Authority
It appears that the citations to sections 366.05(9), (11); 366.08, and 366.093(1), Florida Statutes, should be cited as laws implemented as opposed to rulemaking authority. Please review and revise.


