You have asked this firm to provide you with its opinion as to whether the recently purchased Charlie Creek Utilities is subject to the Public Service Commission's jurisdiction.

I understand that this Utility is located in Hardee County, provides water service to more than 100 people and charges for water service. You are correct that although Hardee County utilities were originally excluded from the PSC's jurisdiction pursuant to Section 367.171(3), Florida Statutes, the County adopted Resolution 2009-02, transferring jurisdiction of water and wastewater utilities to the PSC effective October 26, 2009. At that time the PSC would have contacted all utilities in the County and DEP data bases advising of the transfer of jurisdiction to the PSC. I am unable to determine whether Charlie Creek Utilities was so contacted.

In conclusion, Charlie Creek Utilities is subject to the PSC's jurisdiction and should obtain a Certificate pursuant to Section 367.045, Florida Statutes. I would suggest you contact the PSC (I suggest Patti Daniel at 850-413-6808) to advise of your situation, and file the appropriate application at your earliest opportunity.
