Dear Sir/Madam:

Summit Broadband, Inc. ("Summit Broadband"), by undersigned counsel and on behalf of Marco Island Cable, Inc. ("Marco Island Cable"), responds to the Notice of Proposed Agency Action issued in the above-referenced matter on May 11, 2015 ("Notice").¹ In the Notice, the Commission advised that Marco Island Cable had failed to pay the 2014 Regulatory Assessment Fee ("RAF") pursuant to Rule 25-4.0161, F.A.C. and ordered Marco Island Cable to pay the 2014 RAF, a \$500 penalty for a first-time violation, and statutory late payment charges.

Enclosed please find a check in the amount of \$1,244 as payment for Marco Island Cable's 2014 RAF and associated penalties and interest. The \$1,244 amount was calculated as follows: (1) \$600 for the 2014 RAF; (2) \$500 penalty for a first-time violation per Rule 25-4.0161(12)(a), F.A.C.; (3) \$120 penalty for payment remitted four months after the January 30 due date per 350.113(4), F.S.; and (4) \$24 interest for late payment per Rule 25-4.0161(9)(b), F.A.C. In addition, I have enclosed a check in the amount of \$600 as payment for Marco Island Cable's 2015 RAF. By letter dated June 1, 2015 and addressed to the Commission Clerk, Summit Broadband requested that Marco Island Cable's CLEC Certificate No. 8663, be cancelled immediately. Therefore, Marco Island Cable is no longer subject to a RAF.

Given that Marco Island Cable's 2014 RAF, including all penalties and interest imposed for late payment, has been paid in full, in accordance with the Notice, Summit Broadband respectfully requests the Commission to close Docket No. 150131-TX. Please contact me if you have any questions regarding this issue.
