Commissioners; I am writing concerning Docket No. 150102-SU.

HISTORY:

A few years ago the Sandalhaven Utilities was a privately held profitable Utility, they wanted to sell the Utility, Charlotte County made them a very good offer but the Corporation that now owns Utilities Inc. offered them almost Two Million more and purchased the Utility.

Now because of a bad business decision Utilities Inc. keeps coming to the Florida Public Service Commission to have the rate payers cover their bad business decision. Two years ago they received an 80% rate increase from Base rate of \$19.00 per month to a Base rate of \$29.00 per month.

Utilities Inc. with their creative book keeping can show you that they are not making a profit. Cases in point of creative book keeping. The Insurance Companies in Florida wanted a rate increase; and according to the investigative reporters of the Herald Tribune they were pushing all of the profits to their Main offices in other states and showing big losses in Florida. Also the Enron Corporation (no longer in existence) who owned electrical utilities and keep raising rates; whose president was scheduled to go to prison but died of a heart attack before going to prison.

I have attached a water and sewer charge of (one of my friends who lives in Rotunda) and has water and sewage with Charlotte County. Their Sewer base rate is \$29.36 per month and their base rate for water is \$18.41 and a customer charge of \$3.50 For a Total of <u>\$57.27</u>.

I also am attaching a bill from South Bend Indiana (a town of approximately 130,000 residents) where we own a condominium. They furnish water, water service insurance into the condo, sewer, sewer insurance into the condo, trash removal, recycling, Fire Hydrant protection, all for a Total of **\$55.06**.

I DON'T BELIEVE UTILITIES INC. SHOULD CHARGE A BASE RATE MORE THAN CHARLOTTE COUNTY. \$29.36

THE RATE PER 1000 GALLONS SHOULD NOT BE ANY MORE THAN CHARLOTTE COUNTY CHARGES, BECAUSE UTILITIES INC. IS PUMPING OUR WASTE WATER TO CHARLOTTE COUNTY AND THEY ARE TREATING IT AND DISPOSING OF THE TREATED WATER.

IF THIS IS A HARDSHIP FOR THEM THEY SHOULD SELL THE UTILITY TO CHARLOTTE COUNTY.

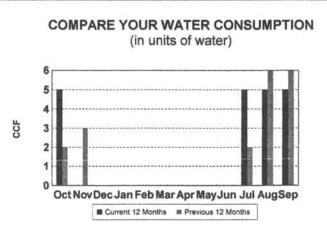
