By this letter, the Commission staff requests that Black Bear Waterworks, Inc. (utility) provide responses to the following data request.

Referring to Exhibit H, Table 1 and Table 2 filed with your application for transfer. Please explain the discrepancies identified below and provide any documents that support your explanations.

- 1. In Table 1, for NARUC Account 304: Structures and Improvements, 28 years was used for the life instead of 27 years, as called for by Rule 25-30.140, Florida Administrative Code.
- 2. In Table 1, for all the accounts, 11.5 years was used as the age of the system, instead of 11 years.
- 3. In Table 1, for the Handy Whitman indexes for all the accounts, staff could not find the indexes referenced in Footnote 1.
- 4. In Table 1, the flow meters were placed in NARUC Account 334: Meters, Meter Installations, and not NARUC Account 309: Supply Mains.
- 5. Table 2 lists two 6" flow meters, instead of one 6" and one 3" flow meter as noted in your assets list.
- 6. Table 2 lists two storage tanks and not three as noted in your assets list.
