BOCILLA UTILITIES, INC. (3) Charlotte County has requested that the Utility provide private fire protection service to its fire station located on Bocilla Island (see letter attached hereto as Exhibit "A"). The Utility does not have any private fire protection customers and therefor does not have an approved Private Fire Protection Service rate. Rule 25-30.465, Florida Administrative Code, sets a "default" private fire protection service rate at 1/12th of the current base facility charge for a 4" meter, unless the Utility justifies some other rate.

(4) The Utility proposes rates consistent with the "default" rate in Rule 25-30.465, F.A.C., and attached hereto as Exhibit "B" is Original Sheet No. 14.1.

(5) Pursuant to Section 367.091(5), Florida Statutes, the Utility will implement this new class of service upon the connection of the County's fire line to the Utility's main.

WHEREFORE, BOCILLA UTILITIES, INC., requests (1) that the Commission approve the approve a new class of service for private fire protection service; and (2) that the Commission approve the attached water tariff sheet implementing this new class of service.

RE: Private Fire Protection Water Tariff

Dear Mr. Noden:

Please consider this correspondence as Charlotte County's formal request to Bocillia Utilities, Inc., that the utility make application to the Florida Public Service Commission (FPSC) for an amendment to its Tariff to add rates for Private Fire Protection Service.

Charlotte County recently acquired an existing fire station on Don Pedro Island that is located at 101 Gasparilla Way. Charlotte County recently awarded a contract for installation of a fire sprinkler system for the fire station. A dedicated fire line is required in order for the sprinkler system to operate properly. Unfortunately, the current FPSC approved Tariff for Bocilla Utilities does not include a rate for Private Fire Protection Service, so Charlotte County cannot connect the fire sprinkler system until a rate for such service is approved by the FPSC.

Time is of the essence in obtaining FPSC approval for Private Fire Protection Service rates and Charlotte County, therefore, respectfully requests that Bocilla Utilities, Inc. file a petition with the FPSC to amend its Tariff to include such rates as soon as possible. Expedited processing of the Tariff Amendment by FPSC will ensure protection of improvements and equipment that cannot be located in the building until the fire suppression system is operational.
