Re: PSC Docket No. 140226-EI, Energy Efficiency Opt-Out By Certain Customers

Dear Chairman Graham and Commissioners,

I write to you in my continuing support of the Florida Legislature's policy of encouraging maximum efficiency of energy use in our State. I understand that, in your pending "Opt-Out Docket," you are considering whether to allow customers who satisfy certain eligibility criteria to "opt out" of participating in, and paying for, a utility's energy efficiency programs, provided that they achieve defined energy efficiency gains at their own expense. I further understand that one group of your Staff recommend rejecting this proposal outright, while another group recommends approving a pilot program to see how it will work.

This concept seems to have exception merit, in that eligible customers would have to satisfy PSC-determined efficiency gains at their own expense, in return for which those customers would not participate in the utility's energy efficiency programs and would not pay for those programs. It seems to me that such customers should be in the best position to implement maximum energy efficiency measures most cost-effectively, rather than being limited only to a utility's programs.

I further understand that your alternative Staff recommendation proposes a workshop process to define the eligibility criteria and other aspects of the pilot program. This seems like a worthy endeavor. However, I am troubled by the Staff's proposal that would limit participation to a relatively few very large customers. I am even more troubled by the apparent fact that the proposed limit would effectively exclude the State's large commercial customers, whose individual accounts use less than the Staff's proposed thresholds but who in the aggregate use many times more than the Staff's recommended threshold. The commercial sector in Florida uses more than one-third of all electricity consumed in the State, and it simply makes no sense to exclude effectively that entire sector from a pilot program, the purpose of which is to identify and develop additional cost-effective ways of saving energy in Florida.


