Re: Notice of Abandonment of Water and Wastewater Service

Dear Messrs. Sandrock and Graham:

Sun River Utilities, Inc., a Florida corporation ("SRU") owns, operates, manages, and controls a utility that provides water and wastewater service to approximately 120 residents of the community known as River's Edge, in Charlotte County, Florida (the "Utility").

SRU hereby gives its sixty (60) day notice of its intent to abandon, in compliance with Section 367.165 F.S. and Rule 25-30.090, F.A.C., the Utility. SRU will be abandoning the Utility on February 10, 2016.

As is required by Florida Administrative Code Section 25- 30.090, we are providing you with the following information:

(a) The Utility's name and address are:

(f) Both the water system and the wastewater system are to be abandoned.

(g) The reason the Utility is to be abandoned is:

The Utility has been losing money for years. There are not enough residents needing water and wastewater service in the area and, thus, not enough utility fees generated at the permitted rates, to support the cost of running the Utility. SRU has made diligent efforts to find another party that would take over ownership and management of the Utility, but these efforts have been unsuccessful. SRU wishes to no longer own and manage the Utility.

(h) The status of the Utility with the Florida Department of Environmental Protection regarding outstanding citations or violations is:

There are no outstanding citations or violations of which SRU is aware.

We will cooperate to help make this a smooth transition. Thank you very much for your attention to this matter.
