CITIZENS' DIRECTIONS TO CLERK OF THE FLORIDA PUBLIC SERVICE COMMISSION AND STATEMENT OF ACTS TO BE REVIEWED

Pursuant to Rule 9.200(a)(3), Florida Rules of Appellate Procedure, the Citizens of the State of Florida ("Citizens"), through the Office of Public Counsel ("OPC"), hereby direct the Clerk of the Florida Public Service Commission to include in the record described in Rule 9.220, Florida Rules of Appellate Procedure, the items identified herein.

Within these Directions, "OPC" or "Citizens" means the Office of Public Counsel; "FPUC" refers to Florida Public Utilities Company; "FIPUG" is the acronym for the Florida Industrial Power Users Group, "FRF" means the Florida Retail Federation, "PCS" means White Springs Agricultural Chemicals, Inc. d/b/a PCS Phosphate – White Springs, "Duke" means Duke Energy Florida, LLC, "TECO" means Tampa Electric Company, "GPC" means Gulf Power Company, and "FPL" means Florida Power & Light Company

As stated in Citizens' Notice of Administrative Appeal, in the above 1. case, Citizens' appeal Order No. PSC-15-0586-FOF-EI. Order No. PSC-15-0586-FOF-EI was Final Order Approving Expenditures and True-Up Amounts for Fuel Adjustment Factors; GPIF Targets, Ranges, and Rewards; and Projected Expenditures and True-Up Amounts for Capacity Cost Recovery Factors ("2015 Fuel Order"). As discussed in the Statement of Acts to be Reviewed below, Citizens' appeal involves only FPUC-related issues. Accordingly, unless otherwise specifically listed below, please exclude from the record on appeal all pleadings, orders, prefiled testimony, transcripts of hearings, exhibits, and all other documents in the docket file of Docket No. 150001-EI that relate to and are associated with the petitions filed by Duke, TECO, Gulf, and FPL. It is the general intent of these Directions to exclude all documents that relate solely to utilities other than FPUC, and to include documents that relate to or bear upon issues involving FPUC.

With respect to the pleadings, testimony, and exhibits relating to and associated with the petitions for approval submitted by Florida Public Utilities Company in Docket No. 150001-EI, Citizens direct the Clerk to include in the record on appeal only the following portions of the docket file in Docket No. 150001-EI:
