SECTION 63.71 APPLICATION

Pursuant to Sections 63.71 of the Commission's Rules¹ and Section 214(a) of the Communications Act of 1934, as amended,² Smart City Telecommunications LLC d/b/a Smart City Telecom ("Smart City Telecom" or the "Company") hereby files this application to discontinue the provision of certain operator services to customers that the Company serves in the State of Florida ("Application").³ In support of this Application, Smart City Telecom submits the following:

B. Date of Planned Service Discontinuance

Smart City Telecom will discontinue Busy Line Verification and Busy Line Interrupt services to its customers in the State of Florida on or about August 1, 2016, or upon completion of all necessary federal and state regulatory approvals.

C. Points of Geographic Areas of Service Affected

Affected Smart City Telecom local exchange customers are in the Company's service area in the Celebration and Lake Buena Vista exchanges in Osceola and Orange Counties, Florida.

D. Brief Description of the Types of Service Affected

In the areas referenced above, Smart City Telecom provides the following services which will be discontinued (collectively, "Affected Services):

Busy Line Verification – An operator service allowing the operator to confirm when a line is idle or in use.

Busy Line Interrupt - An operator service allowing the operator to break into a conversation when a line is in use.

This discontinuance is limited to the Affected Services.

II. Brief Description of the Dates and Methods of Notice to All Affected Customers

Notices were sent to all Smart City Telecom local exchange customers by method of U.S. Mail on May 5, 2016. Please reference Exhibit A which is a sample copy of the Notice sent to the affected customers.

III. Status of Carrier

Smart City Telecom is an incumbent local exchange carrier and considered a dominant carrier with respect to the services that it proposes to discontinue in the State of Florida.

IV. Circumstances of Discontinuance

The Company's discontinuance of the Affected Services was a business decision based on a lack of customer demand for the service. There were no requests at all for the Affected Services over the last two (2) years. The Company's customers are using new technologies and choosing widely available alternatives to Busy Line Verification and Busy Line Interrupt and will not be adversely affected by the Smart City Telecom's discontinuance of Affected Services.


V. **Certification**
