NOTICE IS HEREBY GIVEN ON THIS 15th day of June, 2016, pursuant to Rule 1201.44, Florida Administrative Code, that Camachee Cove Yacht Harbor UTI has filed a petition for a limited proceeding rate increase for water service with the Florida Public Service Commission. The reason for the requested increase is to achieve the revenues previously authorized in the utility's staff-assisted rate case, plus the additional revenues authorized by approved price indices since the issuance of the order in the previous rate case, and to recover an allowance for the estimated rate case expenses and regulatory assessment fees related to making this change in rates.
