

FAR NOTICE OF PREHEARING AND HEARING

The FLORIDA PUBLIC SERVICE COMMISSION announces a prehearing conference and a hearing in the following docket to which all persons are invited.

DOCKET NOS. AND TITLES: Docket No. 160021-EI - Petition for rate increase by Florida Power & Light Company; Docket No. 160061-EI - Petition for approval of 2016-2018 storm hardening plan, by Florida Power & Light Company; Docket No. 160062-EI - 2016 depreciation and dismantlement study by Florida Power & Light Company; Docket No. 160088-EI - Petition for limited proceeding to modify and continue incentive mechanism, by Florida Power & Light Company.

The purpose of this prehearing conference is to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify exhibits; (5) establish an order of witnesses; and (6) consider such other matters as may aid in the disposition of the action.

HEARING DATE AND TIME: Monday, August 22, 2016, at 9:30 a.m., August 23-26, 2016 and August 29, 2016 – September 2, 2016, have also been reserved for continuation of the hearing, if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of the hearing is to permit parties to present testimony and exhibits relative to the application for a rate increase by Florida Power & Light Company, and for such other purposes as the Commission may deem appropriate.
