St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Preliminary List of Issues and Positions to be taken up at the Hearing now scheduled to begin **November 02, 2016** in the above listed docket.

Issue 1: What are the final conservation cost recovery true-up amounts for the period January through December **2015**?

SJNG's Position: **\$61,344 underrecovery.**

Issue 2: What are the total conservation cost recovery amounts to be collected during the period **January 2017** through **December 2017**?

SJNG's Position: An Under-recovery of **\$180,522.**

Issue 3: What are the conservation cost recovery factors for the period January **2017** through December **2017**?

SJNG's Position: **\$0.40001** per therm for RS-1, **\$0.24504** per therm for RS-2, **\$0.18566** per therm for RS-3, **\$0.16949** per therm for GS-1, **\$0.07674** per therm for GS-2, and **\$0.03555** per therm for FTS-4.

Issue 4: What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG'S Position: The effective date should be January 1, **2017.**
