- 5. The utility previously estimated total rate case expense of \$5,300, including \$4,800 in accounting fees and a \$500 filing fee, as shown on page 5 of the utility's application. Please provide an update of that estimate, including any additional fees or expenses incurred to date and anticipated to be incurred through the Proposed Agency Action phase of the case. Please include a detailed breakdown of all costs, along with any necessary supporting documentation, such as invoices or receipts.
- Please provide the utility's billing data by customer class and meter size for each month of the calendar year ended December 31, 2015. In addition, please also provide the utility's billing data by customer class and meter size for each month through November 30, 2016.
