## SEMINOLE ELECTRIC COOPERATIVE'S NOTICE OF WITHDRAWAL OF REQUEST FOR CONFIDENTIAL CLASSIFICATION

Seminole Electric Cooperative, Inc. ("Seminole") pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), hereby serves notice that it withdraws its Second Request for Confidential Classification for certain documents and information provided in Response to Staff's First Set of Interrogatories and First Request for Production of documents. In support, Seminole states as follows:

- 1. On January 29, 2018, SECI responded to Staff's First Set of Interrogatories and First Request for Production of Documents. Certain confidential documents and information (DN 00736-2018) were submitted with a Notice of Intent to Request Confidential Classification (DN 00735-2018) pursuant to Rule 25-22.006, Florida Administrative Code.
- 2. On February 16, 2018, SECI filed its Second Request for Confidential Classification (DN 01396-2018) for this same confidential information (DN01397-2018).
- 3. Subsequently, and pursuant to discussions between counsel for Seminole and counsel for Staff, it was determined that Staff would return the confidential

documents provided with Seminole's Notice and Second Request to Seminole. Following the return of the documents, Seminole would withdraw its pending request for confidential classification.

- 4. On February 28, 2018, the Commission Clerk returned the confidential documents and information (DN 00736-2018 and DN 01397-2018) to Seminole.
- 5. Accordingly, Seminole withdraws its Second Request for Confidential Classification (DN 01396-2018).
