Please see the Joint response to your follow up question.

### RESPONSE:

DEF and PRECO do not anticipate any new phosphate mining customers requesting retail electric service in PRECO's service territory. However, should any new phosphate mining customers request retail electric service within PRECO's service territory, those customers will be served by PRECO unless it is not operationally feasible for PRECO to serve these customers. Should PRECO decide it is not operationally feasible to serve these customers, PRECO would request DEF to serve such customers and the Parties would jointly petition the PSC in an amended agreement for approval for DEF to serve.

Good morning Sevini,

Please see the joint response to question 2, below.

### Response:

At the Open House, thirty-two customers who would be subject to transfer to PRECO should the agreement be approved, attended. The concerns were regarding the differences in rates, what types of residential home services PRECO offers in comparison to DEF, seasonal rates, and deposit questions. PRECO and Duke had several representatives present to answer any questions, including customer service representatives. There were no outstanding concerns after the Open House.

Additionally, DEF has received thirty-four calls on the toll-free line for this project. Of those, six customers left a voicemail with questions regarding any requirements the customer would need to do to receive service from PRECO, automated billing questions, and when would service begin being provided by PRECO. All customers were called and any questions and concerns were discussed directly with the customers. At this time, there are no known unresolved issues.

PRECO received no calls on its dedicated toll-free line for this project. PRECO's call center received two calls: one seeking clarification on deposits, the other seeking clarification on their service provider once the Territorial Agreement is approved. PRECO's customer service representative discussed both questions directly with the callers, and there are no known unresolved issues at this time.


