Dear Mr. Smallridge:

Staff reviewed the application for transfer submitted on January 22, 2021, on behalf of Arma Water Services, LLC and Leighton Estates Utilities. After reviewing this information, we find the application to be deficient. The specific deficiencies are identified as:

1. **Filing Fee.** Rule 25-30.037(2)(a), Florida Administrative Code (F.A.C.), requires that the applicant remit a filing fee pursuant to Rule 25-30.020(2)(c), F.A.C., which states:

For an application for transfer or change in majority organizational control filed pursuant to Section 367.071, Florida Statutes, the amount of the fee shall be as follows:

1. For applications in which the utility to be transferred has the capacity to serve up to 500 ERCs, \$750;

Therefore, with 188 ERCs (equivalent residential connections) for water, the correct filing fee for the application is \$750. Please remit the appropriate filing fee.

2. **Assets and Liabilities.** Rule 25-30.037(2)(j)(3), F.A.C., requires a list of and the dollar amount of the assets purchased and liabilities assumed or not assumed, including those of nonregulated operations or entities. Please provide a list of the specific assets and liabilities including the dollar amount allocated to each.

Your application will not be deemed filed until the deficiencies identified in this letter have been corrected. These corrections should be submitted no later than **April 13, 2021**, to the following address:
