2	CHAIRMAN CLARK: Next up is Item No. 14.
3	Mr. Futrell.
4	MR. FUTRELL: Item 14 is staff's
5	recommendation addressing the apparent fourth-time
6	regulatory assessment fee rule violation of Optical
7	Telecommunication Services doing business as H
8	Control Corporation, doing business as SH Services,
9	LLC, a local exchange carrier.
10	Pursuant to the Commission's RAF rule for
11	telecommunications company, the Commission has the
12	authority and also discretion to either cancel the
13	company's certificate or waive the cancellation if
14	the RAF's and all penalties, interest and late
15	payment charges are paid in full. Prior to the
16	filing of this recommendation on May 20th, 2021
17	SH Services fully satisfied the outstanding RAF fee
18	balance and all accrued statutory late-payment
19	charges, as well as proffered an estimated penalty
20	for fourth-time RAF rule violation in the amount of
21	\$4,000.
22	The regulatory assessment fee rule does not
23	specific a penalty amount for a fourth-time rule
24	violation. However, this \$4,000 penalty amount was
25	approved by the Commission in a prior case of

	1	fourth-time rule violation at Docket No.
	2	20200141-TA. Staff recommends that the Commission
	3	recognize SH Services payment of penalty and cost
	4	of collection towards a fourth violation in the
	5	amount of \$4,000 is the correct and satisfactory
	6	penalty amount in this case. On this basis, staff
	7	recommends the company's tariff and registration
	8	not be canceled nor removed from the register.
	9	No public comments have been received on this
	10	matter and oral modification to the staff
	11	recommendation has been provided to your offices
	12	and has been placed in the docket file. A
	13	representative of SH Services is available for
	14	questions, as is staff.
	15	CHAIRMAN CLARK: All right. This item was
	16	pulled because of an oral modification. Do any
	17	Commissioners have any questions, comments? I'll
