Subject: TECO proposed rate hike

To whom it concerns;

I am writing regarding the proposed rate hike by Tampa Electric Co (TECO). Every year TECO and other utilities continue to petition for rate hikes and some are granted and some have been denied (rarely). This proposed rate hike is unnecessary and it is excessive in it's amount.

First the growth in TECO's coverage area of new homes and other building has given them a windfall of income with little improvement of services to warrant a rate hike. Sure there is a cost to maintaining and adding new systems to meet demand but this cost which mostly should have already been factored in their operating budgets, is certainly met with the increase in customers they did not have in prior years. We are talking about hundreds of families per day moving into this coverage area. Multiplied by the average electric bill gives TECO Millions in new funds.

As for the amount of the requested increase. The proposed increase asks for a change to both the Basic Service Charge, and the Energy and Demand Charge for Standard Residential Rates. The Basic Service Charge will increase by 0.20 cents per day and the Energy charge will increase by 1.375 cents per kilowatt hour (kWh) for the first 1000 kWh and the same amount 1.375 cents per kWh for all additional kilowatts.

On the surface this does not seem like a lot but this is where the consumer takes a beating as it appears to only be a few cents. Let's look at a demonstration of a small home of 1400 sq ft using the same amount of kWh per month of 1400. This would normally be a basic charge of \$15.05 going up to \$15.75. Then the Energy charge for 1400 kWh would normally be \$52.25 going to \$66.00 for the first 1000 kWh and then the remaining 400 kWh would normally be \$24.90 going to \$30.40.

This proposed increase would have consumers for this small house seeing an increase in their electric bill of \$19.95 a month. Plus the costs for a Fuel charge, plus storm protection charges, and taxes. Which since fuel has gone down from the highs a several years ago when the fuel charges became necessary yet they have never been removed. Fuel charges are per kWh as well and for this example home would be about an additional \$44.38. So by the time the consumer in such a small home receives their bill they are looking at a steady line of increase resulting in additional expenses on them in a time when many are still hurting from Covid -19. The bill in this example would be \$160.49 before taxes. more than a \$30 increase per month. This is enough to put some home budgets in the red and possibly out of electricity.

Please review this proposal carefully and deny this proposed increase.
