#### PURPOSE AND PROCEDURE:

The purpose of this hearing is to consider the petition of Florida Power & Light Company in Docket No. 20210015-EI for an increase in its rates and consolidation of its rates with those of Gulf Power Company, to take testimony on the Stipulation and Settlement Agreement dated August 9, 2021, and to consider any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on August 2, 2021, as well as on the Stipulation and Settlement Agreement dated August 9, 2021. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
